Addendum

The following communication, received on 9 December 2024, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Rimsulfuron

The proposed maximum residue limit (PMRL) document for rimsulfuron notified in G/SPS/N/CAN/1568 (dated 11 September 2024) was adopted 4 December 2024. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.01 Pome fruits (crop group 11-09)

¹ ppm = parts per million
