## NOTIFICATION

### Addendum

The following communication, received on 9 December 2024, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Clomazone

The proposed maximum residue limit (PMRL) document for clomazone notified in G/SPS/N/CAN/1567 (dated 11 September 2024) was adopted 4 December 2024. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.05 Pulses, dried shelled beans, except soybeans (crop subgroup 6-21E)

<sup>1</sup> ppm = parts per million
