Description of content: The Order introduces amendments to the Requirements for chicken eggs, as approved by the Order of the Ministry of Agrarian Policy and Food No. 360 of 7 March 2023, in terms of requirements for stamping and labelling of eggs, minimum shelf life of eggs, use of open-air runs, indication of 'eggs obtained from free-range laying hens'. These amendments are aligned with Commission Delegated Regulation (EU) 2023/2464 of 17 August 2023 amending Regulation (EU) No 1308/2013 of the European Parliament and of the Council, as regards marketing standards for eggs and Commission Delegated Regulation (EU) 2023/2465 of 17 August 2023 supplementing Regulation (EU) No 1308/2013 of the European Parliament and of the Council as regards marketing standards for eggs, and repealing Commission Regulation (EC) No 589/2008. The Order is also notified under the TBT Agreement.
