Description of content:** This Draft Uganda Standard applies to the rhizome of commercial varieties of ginger grown from Zingiber officinale Roscoe, of the *Zingiberaceae* family, to be supplied fresh to the consumer, after preparation and packaging. Ginger for industrial processing is excluded.
