Established Maximum Residue Limits: Spiromesifen

The proposed maximum residue limit (PMRL) document for spiromesifen notified in G/SPS/N/CAN/1573 (dated 4 October 2024) was adopted 25 December 2024. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:
