Description of content: The notified Order suspends, for a period of one year, the entry and import into France, and the placing on the market in France, whether free of charge or in return for payment, of food supplements containing the plant <i>Garcinia cambogia Desr.</i> and all preparations made from part of this plant. Products already on the market must be withdrawn. It enters into effect on 16 April 2025.
7.	Objective and rationale: [X] food safety, [] animal health, [] plant protection, [] protect humans from animal/plant pest or disease, [] protect territory from other damage from pests.
8.	Nature of the urgent problem(s) and reason for urgent action: The Order was issued following the opinion of the Agency for Food, Environmental and Occupational Health and Safety (ANSES) of 12 February 2025, published on 5 March, highlighting the acute risk associated with the consumption of food supplements containing extracts of <i>Garcinia cambogia Desr</i> . for people with a history of medical problems but also for those in good health.
