The "Quarantine Requirements for the Importation of Regulated Objects Related to Decapod Iridescent Virus 1" have been incorporated into the "Import Quarantine Requirements for Live Crustaceans and Molluscs" (G/SPS/N/TPKM/635/Add.1), and this document (G/SPS/N/TPKM/643/Add.1) is proposed for repeal on 8 April 2025.
