Final draft of Health Certificate for Exporting Feed Products to the Kingdom of Saudi Arabia ("Animal origin or containing animal protein" and "Plant origin")

Health certificates were modified based on the comments of Members, with the creation of new certificates as follows:

- Health Certificate for the Export of Non-Production Animal Feed Containing Products of Animal Origin;
- Health Certificate for the Re-export of Feed from a Third Country to the Kingdom of Saudi Arabia;
- Health Certificate for the Export of Animal-Origin Feed Products to the Kingdom of Saudi Arabia;
- Health Certificate for the Export of Plant-Origin Feed Products to the Kingdom of Saudi Arabia.
