Description of content: This Regulation authorises for the first time in the European Union and for a period of ten years a preparation of <i>Lactiplantibacillus plantarum</i> NCIMB 30094 as a feed additive belonging to the additive category 'technological additives' and in the functional group 'silage additives', for all animal species. This authorisation is based on the favourable conclusions of a scientific assessment of the dossier submitted by the applicant, conducted by the European Food Safety Authority (EFSA). The terms of the authorisation are detailed in the Annex to the Act.
