6.	<b>Description of content:</b> This Regulation authorises for the first time in the European Union and for a period of ten years a preparation of <i>Bacillus subtilis</i> DSM 33862 and <i>Lentilactobacillus buchneri</i> DSM 12856 as a feed additive belonging to the additive category 'technological additives' and in the functional group 'silage additives', for all animal species. This authorisation is based on the favourable conclusions of a scientific assessment of the dossier submitted by the applicant, conducted by the European Food Safety Authority (EFSA). The terms of the authorisation are detailed in the Annex to the Act.
