The following communication, received on 17 September 2025, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limits: Florylpicoxamid

The proposed maximum residue limit (PMRL) document for florylpicoxamid notified in [G/SPS/N/CAN/1594](https://www.wto.org/trade-portal/notifications/notifications.htm?n=1594) (dated 19 June 2025) was adopted 15 September 2025. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.5	Mangoes
0.4	Bananas

¹ ppm = parts per million
