#### **CIRCULAR**

### Regulations on quarantine of terrestrial animals and animal products

Pursuant to the Law on Veterinary Medicine 2015;

Pursuant to the Law on Food Safety 2010;

Pursuant to Decree No. 35/2025/ND-CP dated February 25, 2025 of the Government stipulating the functions, tasks, powers and organizational structure of the Ministry of Agriculture and Environment;

Pursuant to Decree No. 15/2018/ND-CP dated February 2, 2018 of the Government detailing the implementation of a number of articles of the Law on Food Safety;

At the request of the Director of the Department of Animal Health and Production;

The Minister of Agriculture and Environment promulgates a Circular regulating the quarantine of terrestrial animals and animal products.

### Chapter I GENERAL PROVISIONS

### Article 1. Governing of Scope and objects of application

1. Governing of cope

This Circular stipulates:

- a) List of terrestrial animals and animal products subject to quarantine; The list of terrestrial animals and animal products subject to quarantine exemption; The list of terrestrial animals and animal products subject to risk analysis before importing into Vietnam; The list of subjects subject to quarantine of terrestrial animals and animal products;
- b) Contents, dosiers, order and procedures for quarantine of terrestrial animals and animal products transported out of the provincial-level localities; export, import, temporary import for re-export, temporary export for re-import, transfer of border gates, bonded warehouses, transit through the territory of Vietnam and terrestrial animals and animal products carried with people; marking, issuing terrestrial animals identification number, sealing of means of transport, iterms containing terrestrial animals and animal products subject to quarantine;

c) Quarantine and state inspection of food safety for terrestrial animal products used as imported food.

#### 2. Objects of application

This Circular applies to organizations and individuals involved in transporting out of the provincial level; exporting, importing, temporarily importing for re-exporting, temporarily exporting for re-importing, transferring from border gates, bonded warehouses, and transiting through the territory of Vietnam of terrestrial animals and animal products.

#### **Article 2. Interpretation of terms**

In this Circular, the following terms are construed as follows:

- 1. Animal quarantine isolation area is a separate area to keep animals for a certain period of time to carry out quarantine.
- 2. Animal product quarantine isolation area is a warehouse or container to preserve animal products for a certain period of time to carry out quarantine.
- 3. Exported and imported goods are animal products of the same type, same name, product label, product manufacturing facility, and packaging material.
- 4. An imported or exported animal shipment is the entire animal of an imported or exported shipment (with the same bill of lading number).
- 5. A shipment of imported or exported animal products is the entire animal product of an imported or exported shipment (with the same bill of lading number). The shipment may have only one item or many items.
- 6. High-risk animal products are animal products in fresh, chilled, frozen, pre-processed form; raw materials for animal feed and aquatic products must be tested for contamination of ruminant products (DNA).
- 7. Low-risk animal products are animal products that have been processed by industrial or manual methods.
- 8. Clinical inspection is the inspection of animal health status based on direct examination and assessment activities, external symptoms of animals to detect abnormal signs, signs of animal diseases.
- 9. Inspection of the actual condition of goods is the inspection of storage conditions, packaging specifications, appearance of products, types, product labels, detailed information of the shipment.
- 10. The person taking samples for quarantine of animals and animal products must be a civil servant appointed to the specialized civil servant position in animal quarantine or a person with intermediate or higher professional qualifications in animal husbandry, veterinary medicine or animal husbandry and veterinary medicine who has completed a professional training course on animal

and animal product quarantine organized by the Department of Animal Health and Production or agencies authorized by the Department of Animal Health and Production to organize training.

Article 3. List of terrestrial animals and animal products subject to quarantine; The list of terrestrial animals and animal products subject to quarantine exemption; The list of subjects subject to quarantine of terrestrial animals and animal products; The list of terrestrial animals and animal products subject to risk analysis before importing into Vietnam

- 1. List of terrestrial animals and animal products subject to quarantine is specified in Appendix I issued along with this Circular.
- 2. List of terrestrial animals and animal products subject to quarantine exemption is specified in Appendix II issued along with this Circular.
- 3. List of subjects subject to quarantine of terrestrial animals and animal products is specified in Appendix III issued along with this Circular.
- 4. List of terrestrial animals and animal products subject to risk analysis before importing into Vietnam is specified in Appendix IV issued along with this Circular.

# Chapter II QUARANTINE OF TERRESTRIAL ANIMALS AND ANIMAL PRODUCTS

# QUARANTINE TERRESTRIAL ANIMALS AND ANIMAL PRODUCTS TRANSPORTED OUT OF PROVINCIAL-LEVEL LOCALITIES

Section 1

# Article 4. Application for quarantine of animals and animal products transported out of provincial - level localities

- 1. Application for quarantine of animals transported out of provincial level localities according to Form 1a, Appendix V, issued along with this Circular.
- 2. Application for quarantine of terrestrial animal products transported out of provincial level localities according to Form 1b, Appendix V, issued along with this Circular.

# Article 5. Procedures, order and contents of quarantine for animals transported out of the provincial - level localities

### 1. Quarantine registration

Before transporting animals out of the provincial - level localities, the owner of the goods shall submit 01 quarantine registration dosiers as prescribed in Clause 1, Article 4 of this Circular to the provincial-level specialized management agency for Animal Health and Production (hereinafter referred to the domestic animal quarantine agencies), in one of the following forms: via the

Public Service Portal or via the public postal service or via email, fax, then send the original or send directly.

#### 2. Receiving and checking documents

Within 01 working day from the date of receiving the registration documents, the domestic animal quarantine agencies shall review the validity of the documents and notify the owner of the time and place of quarantine. In case the dossier is invalid, the domestic animal quarantine agencies shall respond to the owner in writing or via the public service portal, email or fax and clearly state the reason.

- 3. The quarantine content for animals originating from the facility as prescribed in Clause 1, Article 37 of the Law on Veterinary Medicine, the domestic animal quarantine agencies shall perform as follows:
  - a) Clinical examination;
- b) Sampling or guiding and supervising the sampling of pathogen testing according to the provisions in Appendix XI issued with this Circular;
- c) Sealing and lead-sealing the means of containing and transporting animals;
- d) Guiding and supervising the owner of the goods to disinfect the means of containing and transporting animals;
- d) Issuing Health Certificate: Within 05 working days from the date of quarantine, the domestic animal quarantine agencies shall issue a Health Certificate for the shipment that meets the requirements.
- e) In case the animal does not meet the veterinary hygiene requirements, the animal quarantine agencies shall not issue a Health Certificate and handle it according to regulations.
- 4. The quarantine content for animals originating from establishments recognized as disease-free or having been monitored to be free of pathogens or having been vaccinated and still having protective immunity to diseases as prescribed in Appendix XI issued with this Circular, the domestic animal quarantine agencies shall implement as follows:
- a) Implement according to the provisions at Points a, c, d, Clause 3 of this Article;
- b) Within 01 working day from the date of receiving the quarantine registration, the domestic animal quarantine agencies shall issue a Health Certificate.
- 5. Notify the domestic animal quarantine agencies at the destination via email or fax of the following information: Health Certificate number, date of issue, quantity of goods, purpose of use, vehicle registration number. Implement

the notification immediately after issuing the Health Certificate for animals transported for breeding, summarize weekly notifications for animals transported for slaughter.

# Article 6. Procedures, order and content of quarantine of animal products transported out of the provincial - level localities

#### 1. Quarantine registration

Before transporting animal products out of the provincial - level localities, the owner of the goods shall submit 01 quarantine registration dossier as prescribed in Clause 2, Article 4 of this Circular to the domestic animal quarantine agencies, in one of the following forms: via the Public Service Portal or via the public postal service or via email, fax, then send the original or directly sending.

### 2. Receiving and checking dossiers

Within 01 working day from the date of receiving the registration dossier, the domestic animal quarantine agencies shall review the validity of the dossier and notify the owner of the time and place of quarantine. In case the dossier is not valid, the domestic animal quarantine agencies shall reply to the owner in writing or respond via the Public Service Portal or email or fax and clearly state the reason.

- 3. The quarantine content for animal products originating from the facility as prescribed in Clause 1, Article 37 of the Law on Veterinary Medicine, the domestic animal quarantine agencies shall perform as follows:
  - a) Check the status of goods;
- b) Take samples or guide, supervise the sampling to check veterinary hygiene indicators as prescribed in Appendix XI issued along this Circular;
  - c) Seal and lead the means of containing and transporting animal products;
- d) Guide and supervise the owner to disinfect the means of containing and transporting animal products;
- d) Issue Health Certificate: Within 05 working days from the date of quarantine, the domestic animal quarantine agencies shall issue a Health Certificate for the shipment that meets the requirements.
- e) In case the animal product does not ensure veterinary hygiene requirements, the animal quarantine agencies shall not issue a Health Certificate and shall handle it according to regulations.
- 4. Quarantine contents for animal products originating from preliminary processing, processing and trading establishments that have been periodically inspected for veterinary hygiene according to the provisions in Appendix XI issued along with this Circular:

- a) Implement according to the provisions in points a, c, d and e, Clause 3 of this Article;
- b) Within 01 working day from the date of receiving the quarantine registration, the domestic animal quarantine agencies shall issue a Quarantine Certificate.
- 5. Summarize weekly notifications to the domestic animal quarantine agencies at the destination via email or fax with the following information: Health Certificatenumber, date of issue, type of goods, quantity of goods, purpose of use, vehicle registration number.
- 6. Control of transportation out of the provincial level of frozen and chilled animal products for food after import: Implement according to the provisions in Appendix XIII issued along with this Circular.

#### **Section 2**

### QUARANTINE TERRESTRIAL ANIMALS AND ANIMAL PRODUCTS FOR EXPORT

# Article 7. Application for quarantine registration of exported terrestrial animals and animal products

- 1. Application for quarantine of animals according to Form 2a; animal products according to Form 2b of Appendix V issued along with this Circular;
- 2. Veterinary hygiene requirements of the importing country or the owner of the goods (if any);
- 3. Sample of Health Certificate of the competent authority of the importing country (if any).

# Article 8. Order, procedures, and contents of quarantine of exported terrestrial animals and animal products

### 1. Quarantine registration

Before exporting animals and animal products requiring quarantine, the owner must register for quarantine with the Regional Animal Health and Production Sub-Department or the Provincial Animal Health and Production Sub-Department authorized by the Department of Animal Health and Production (hereinafter referred to the border animal quarantine agencies), in one of the following forms: via the Public Service Portal or via the public postal service or by email, fax, then send the original or directly sending.

### 2. Receiving and checking the dossier

Within 01 working day from the date of receiving the registration dossier, the border animal quarantine agencies shall review the validity of the dossier and notify the owner of the time and place of quarantine. In case the dossier is invalid, the animal quarantine agencies at the border gate shall respond to the owner in

writing or via the public service portal, email or fax, stating the reasons.

- 3. The animal quarantine agencies at the border gate shall perform the following:
- a) Clinical examination of animals and inspection of the actual condition of goods for animal products;
- b) Carry out the contents according to the quarantine requirements of the importing country;
- c) Within 05 working days from the date of commencement of quarantine, if the requirements are met, the animal quarantine agencies at the border gate shall issue a Quarantine Certificate.
- 4. In case the importing country or the owner of the goods does not request quarantine: The owner of the goods must carry out the quarantine of transportation out of the provincial level localities according to the provisions of Article 5 and Article 6 of this Circular.

# Article 9. Control of terrestrial animals and animal products exported at the border gate

- 1. The border gate animal quarantine agencies shall:
- a) Check the Quarantine Certificate;
- b) Confirm or issue the Export Health Certificate upon request of the owner of the goods.
- 2. For animals and animal products that have not been issued an Export Health Certificate, the border gate animal quarantine agencies shall comply with the provisions of Articles 7 and 8 of this Circular.

# Section 3 QUARANTINE OF IMPORTED TERRESTRIAL ANIMALS AND ANIMAL PRODUCTS

# Article 10. Quarantine dosiers for imported animals and animal products

- 1. Dosiers for registration of quarantine for imported animals:
- a) Document requesting quarantine guidance according to Form 19, Appendix V, issued along with this Circular;
- b) For animals under the management of other relevant competent state agencies, documents or licenses must be submitted as prescribed.
  - 2. Dosiers for registration of quarantine for imported animal products:

- a) Document requesting quarantine guidance according to Form 19, Appendix V, issued along with this Circular (for records for registration of quarantine for imported meat and bone meal, the request document is according to Form 20, Appendix V, issued along with this Circular);
- b) For animal products subject to management by other relevant competent state agencies, documents or licenses must be submitted as prescribed.
- 3. Quarantine declaration dossiers for imported animals and animal products
- a) Quarantine declaration form according to Form 3a Appendix V issued along with this Circular;
- b) Photocopy or electronic copy or original Health Certificate of the exporting country (in case the original is not available at the time of declaration, it must be submitted when performing quarantine).

# Article 11. Order, procedures and contents of quarantine of imported animals

- 1. Quarantine registration
- a) Before importing animals, organizations and individuals shall send 01 quarantine registration dosiers according to Clause 1, Article 10 of this Circular to the Department of Animal Health and Production in one of the following methods: via the Public Service Portal or National Single Window or via the public postal service or via email, fax, then send the original or directly sending;
- b) Within 04 working days from the date of receiving valid dossiers based on the epidemic situation, the disease surveillance management system, veterinary hygiene surveillance of the exporting country and other information (if any), the Department of Animal Health and Production shall send a written consent and quarantine instructions to the owner, the animal quarantine agencies at the border gate via email (in case the owner registers for quarantine via the public postal service or sends it via email, fax or sends it directly) or on the National Single Window (in case the owner registers for quarantine on the National Single Window). In case of disagreement, the owner must be replied in writing or responded via the public service portal or email or fax and clearly state the reasons:
- c) In case animals are subject to risk analysis before being imported into Vietnam, the provisions in Appendix IV issued with this Circular must be analyzed by the Department of Animal Health and Production according to the provisions of Article 43 of the Law on Veterinary Medicine.
  - 2. Quarantine declaration
- a) After the Department of Animal Health and Production has a written consent and quarantine instructions, before the goods arrive at the import border gate, the owner of the goods shall send 01 quarantine declaration dosiers as prescribed in Clause 3, Article 10 of this Circular to the animal quarantine agencies at the border gate in one of the following methods: via the Public Service

Portal or National Single Window or via the public postal service or send by email, fax, then send the original or send directly;

- b) Within 01 working day from the date of receiving the valid animal quarantine declaration documents, the animal quarantine agencies at the border gate shall notify the organization or individual declaring the quarantine of the location and time to conduct the quarantine.
  - 3. Imported animal quarantine contents
    The Border animal quarantine agencies implement:
- a) Check the quarantine dosiers, clinically examine the animals; if the quarantine dosiers are valid, the animals show no signs of disease; The quarantine agencies shall seal and lead clamp the means of transport and contain the animals and notify the owner of the goods transporting the animals to the quarantine isolation place or to the inspected location, which has sufficient conditions for quarantine isolation according to Form 14a of Appendix V issued along with this Circular;
- b) Monitor and supervise animals at the quarantine isolation place or at the location with sufficient conditions for quarantine isolation; the quarantine isolation monitoring time is appropriate for each animal species and each disease to be inspected but not more than 45 days from the date of commencement of quarantine isolation;
- c) Take samples or guide and supervise taking samples for testing of pathogens according to the provisions of Appendix XII issued with this Circular; instruct the owner of the goods to take compulsory disease prevention measures for animals that have not been vaccinated according to regulations;
- d) Instruct the owner of the goods to implement hygiene, disinfection and sterilization measures;
- d) Issue an Import Health Certificate for animals that meet the requirements; In case the animal does not meet the veterinary hygiene requirements, the animal quarantine agencies at the border gate will not issue a Health Certificate and will handle the case according to regulations.
- 4. The animal quarantine agencies at the border gate will notify the domestic animal quarantine agencies at the destination of the shipment information immediately after issuing the Health Certificate.

# Article 12. Order, procedures and contents of quarantine of imported animal products

- 1. Quarantine registration
- a) Before importing animal products, organizations and individuals shall send 01 quarantine registration dosiers according to Clause 2, Article 10 of this Circular to the Department of Animal Health and Production in one of the following methods: via the Public Service Portal or National Single Window or via public postal service or via email, fax, then send the original or send directly;

- b) The Department of Animal Health and Production shall implement Point b, Clause 1, Article 11 of this Circular.
- c) In case animal products are subject to risk analysis before being imported into Vietnam, the provisions in Appendix IV issued with this Circular must be analyzed by the Department of Animal Health and Production according to the provisions in Article 43 of the Law on Veterinary Medicine.

#### 2. Quarantine declaration

Implement according to the provisions in Clause 2, Article 11 of this Circular.

3. Quarantine contents of imported animal products

The border quarantine agencies implement:

- a) Check the quarantine dosierds and the status of the goods. If the requirements are met, implement according to the provisions in Appendix XII issued along with this Circular;
- b) The Health Certificate of the exporting country and taking sample are exemted in case the imported goods are for sample purposes and weigh less than 50 kg;
- c) Instruct the owner of the goods to implement hygiene, disinfection and sterilization measures;
- d) Issue Health Certificate: Within 05 working days from the date of quarantine, the border quarantine agencies shall issue an Import Health Certificate for animal products that meet veterinary hygiene requirements;
- e) In case the animal products do not meet veterinary hygiene requirements, the border quarantine agencies shall not issue a Health Certificate and handle them according to regulations.
- 4. The animal quarantine agencies at the border gate shall implement in arcording to the Clause 4, Article 11 of this Circular.
- 5. For exported animal products that are recalled or returned, must be carried out quarantine according to the provisions of Clause 1, Clause 2, Clause 3, Clause 4 of this Article (the owner of the goods is not required to have a Health Certificate from the returning country).

# Article 13. Dosiers, procedures and contents of simultaneously quarantine and state inspection of food safety for imported terrestrial animal products used as food

- 1. Dosiers of simultaneously quarantine declaration and state inspection of food safety for imported terrestrial animal products used as food
  - a) The application for quarantine declaration and registration for imported

food inspection shall be made according to Form 3b Appendix V issued with this Circular;

- b) The components of the dossier specified in Point b, Clause 3, Article 10 of this Circular and Points b, c, d and dd, Clause 2, Article 18 of Decree No. 15/2018/ND-CP dated February 2, 2018 of the Government detailing the implementation of a number of articles of the Law on Food Safety (hereinafter referred to as Decree No. 15/2018/ND-CP).
- 2. The order, procedures and contents of quarantine and state inspection of food safety of imported animal products used as food shall comply with the provisions of Clause 1, Clause 2; Points a, b and c, Clause 3; Clause 4; Clause 5, Article 12 of this Circular and Clause 2, Clause 3, Clause 4, Article 19 of Decree No. 15/2018/ND-CP.
- 3. Within 05 working days from the date of quarantine and state inspection of food safety, the animal quarantine agencies at the border gate shall issue a Health Certificate and a Notice of results confirming that the food meets/fails to meet import requirements according to Form 15c, Appendix V issued along with this Circular.

In the case of state inspection of imported food safety according to the strict inspection method prescribed in Clause 3, Article 19 of Decree No. 15/2018/ND-CP, within 07 working days from the date of quarantine and state inspection of food safety, the Border Quarantine Agency shall issue a Health Certificate and a Notice of results confirming the satisfaction/failure of import requirements according to Form 15c of Appendix V issued with this Circular.

In case of failure to meet import requirements, it shall be handled according to regulations.

# Article 14. Quarantine of animal products exported and imported on the spot

- 1. Animal products that have completed import quarantine procedures, have not been processed or repackaged when exported or imported on the spot are not required to undergo quarantine.
- 2. Animal products of domestic origin, exported to processing enterprises, only need to undergo quarantine when transported out of the provincial level localities according to regulations, and do not need to undergo on-site export and import quarantine.

# Article 15. Quarantine of imported animals and animal products carried along with people

1. The owner of the goods shall declare import quarantine directly at the animal quarantine agencies at the border gate when carrying along people no more than 02 individual animals for ornamental purpose, living in the family or bringing

along for travel, work, transit and not on the List of animals prohibited from export and import according to regulations;

- 2. The owner of the goods must register for import quarantine with the Department of Animal Health and Production according to the provisions of Articles 11 and 12 of this Circular when carrying along people animals and animal products as follows:
  - a) Animals not subject to the provisions of Clause 1 of this Article;
- b) Animal products not subject to the provisions of Clause 3, Part II of Appendix II issued along with this Circular.

#### 3. Quarantine contents

The boder animal quarantine agencies implement:

- a) For animals: Check the Health Certificate of the exporting country; clinical examination of animals; disease prevention by vaccination for animals that have not been vaccinated against dangerous infectious diseases; taking samples for testing of animals suspected of having infectious diseases;
- b) For animal products: Implement according to the provisions of Article 12 of this Circular;
- c) Issuance of Health Certificate: Within 01 working day from the date of quarantine, the border quarantine agency shall issue an Import Health Certificatefor animals and animal products that meet veterinary hygiene requirements;
- d) Make a record and destroy immediately at the area near the border gate for animals with dangerous infectious diseases and animal products that do not meet veterinary hygiene requirements;
- d) In case the Health Certificate of the exporting country is invalid, the border quarantine agency shall make a record to temporarily detain the goods and handle them according to regulations.
- 4. Do not carry with you products of animal origin in fresh or pre-processed form.

# Article 16. Quarantine of imported animal products for processing to export

- 1. Quarantine registration
- a) Before importing animal products, organizations and individuals shall send 01 quarantine registration dossiers according to Clause 2, Article 10 of this Circular to the Department of Animal Health and Production in one of the following methods: via the Public Service Portal or National Single Window or via public postal service or via email, fax, then send the original or send directly;

b) The Department of Animal Health and Production shall implement in arcording to the Point b, Clause 1, Article 11 of this Circular.

#### 2. Quarantine declaration

Implement in arcording to the provisions of Clause 2, Article 11 of this Circular.

- 3. Terrestrial animal products for processing to export: Meat, ears, tail, legs, wings of cattle and poultry imported into Vietnam for processing to export must be conducted quarantine and accompanied with export quarantine certificate issued by the veterinary authority of exporting country stating: Name and address of exporting company; name and address of the factory; name and address of the company imported processed products; products derived from animals of the region, establishments without animal diseases related to those animals in accordance with the provisions of the World Organization for Animal Health (WOAH); products derived from animals that are inspected before and after slaughter; product packaging, preservation ensure veterinary hygiene; uses to make food for humans.
- 4. Quarantine contents for imported animal products for processing to export are as follows.
- a) Check the quarantine dosiers and the status of the goods, if meet the requirements, implement in arcording to the regulations in Appendix XII issued along with this Circular;
- b) Instruct the owner of the goods to implement hygiene, disinfection and sterilization measures;
  - c) Issue a Health Certificate:

Within 05 working days from the date of quarantine, the Border Quarantine Agencies shall issue an Import Health Certificate for animal products that meet veterinary hygiene requirements;

In case the animal products do not meet veterinary hygiene requirements, the Border Quarantine Agency shall handle in according to regulations.

- 5. The Border Quarantine Agencies shall inform to the domestic animal quarantine agencies at the destination about the information of consignment immediately after issuing the Imported Health Certificate.
- 6. The domestic animal quarantine agencies receives information about the consignment of goods, organizes inspection, supervises the processing process, conducts quarantine and issues Health Certificates for processed products transporting out of provincial level localities according to regulations.
- 7. The border animal quarantine agencies conducts quarantine and issues export Health Certificates for processed products according to the requirements

of the importing country or the owner of the goods.

- 8. Only allow to process products for exporting in the production facilities that meet veterinary hygiene or equivalent and meet the requirements of importing countries. The owner of the goods is responsible for transporting, preserving and processing for the correct purpose of use according to the quarantine registration and quarantine declaration.
- 9. Animal products after processing, when export must be quarantined according to quarantine regulations on exported animal products.

#### **Article 17. Notice of violation**

Upon detecting violation of imported consignments on checked indicators, the Department of Animal Health and Production notices in writing to the Animal Health Agency authorized of exporting countries, request to investigate the causes, conducting corrective action and send the report to the Department of Animal Health and Production.

#### **Section 4**

### QUARANTINE TERRESTRIAL ANIMALS AND PRODUCTS TEMPORARILY IMPORTED FOR RE-EXPORT, TEMPORARY EXPORTED FOR RE-IMPORT, TRANSFERRED FOR BORDER GATE, BONDED WAREHOUSE, TRANSIT VIA VIETNAM TERRITORY

- Article 18. Quarantine dosiers of terrestrial animals and animal products temporarily imported for re-export, temporarily exported for re-import, bonded warehouses, transferred for border gates, transited via Vietnam territory
- 1. Quarantine registration dosiers of terrestrial animals and animal products temporarily imported for re-export, temporarily exported for re-import, transferred for border gates, transited via Vietnam territory:
- a) Document requesting quarantine instructions according to Form 17 Appendix V issued along with this Circular;
  - b) Commercial contract;
- c) For animals and animal products subject to management by other relevant competent state agencies, documents or licenses must be submitted as prescribed.
- 2. Application for quarantine registration of animals and animal products imported and exported from bonded warehouses:
- a) Document requesting quarantine instructions according to Form 18 Appendix V issued along with this Circular;
  - b) Commercial contract;

- c) For animals and animal products subject to management by other relevant competent state agencies, documents or licenses must be submitted as prescribed.
- 3. Application for quarantine declaration of terrestrial animals and animal products temporarily imported for re-export, temporarily exported for re-import, transferred from border gate or transited via Vietnamese territory:
- a) Quarantine declaration form according to Form 3a Appendix V issued with this Circular;
  - b) Health Certificate of the exporting country.
- 4. Quarantine declaration dossier for animals and animal products imported and exported from bonded warehouses:
- a) Quarantine registration form according to Form 2a or Form 2b Appendix V issued with this Circular for animals and animal products exported to other countries or foreign cruise ships;
- b) Quarantine declaration form according to Form 3a Appendix V issued with this Circular;
  - c) Health Certificate of the exporting country.

Article 19. Order, procedures and contents of quarantine of terrestrial animals and animal products temporarily imported for re-export, temporarily exported for re-import, transferred from border gate to border gate, and transited via territory of Vietnam

- 1. Quarantine registration
- a) Before temporarily importing, temporarily exporting, re-importing, transferring from border gate to border gate, and transiting through the territory of Vietnam of animals and animal products, the owner of the goods shall submit 01 quarantine registration dossiers as prescribed in Clause 1, Article 18 of this Circular to the Department of Animal Health and Production in one of the following methods: via the National Single Window or via public postal service or via email, fax, then sending the original or sending directly;
- b) The Department of Animal Health and Production shall implement in arcording to the provisions of Point b, Clause 1, Article 11 of this Circular.
  - 2. Quarantine declaration
- a) After the Department of Animal Health and Production has a written consent and quarantine instructions, before the goods arrive at the import border gate, the owner of the goods shall send 01 quarantine declaration dosiers specified in Clause 3, Article 18 of this Circular to the animal quarantine agencies at the border gate in one of the following methods: via the National Single Window or via the public postal service or via email, fax, then send the original or directly

sending.

- b) The border gate quarantine agency shall implement in arcording to the provisions of Point b, Clause 2, Article 11 of this Circular.
- 3. Quarantine contents of terrestrial animals and animal products temporarily imported for re-export, temporarily exported for re-import, transferred to border gates, and transited via territory of Vietnam

The animal quarantine agencies at the border gate shall implement in arcording to the provisions of Article 50 of the Law on Veterinary Medicine.

The animal quarantine agencies at the border gate shall keep a copy of the Health Certificate of the exporting country in the quarantine file. The original Health Certificate of the exporting country shall be returned to the owner of the goods.

4. In case of changing the export gate when the shipment has arrived at the export gate, the animal quarantine agencies at the original planned re-export gate shall confirm the agreement to move to another gate if the re-export gate has been approved by the Department of Animal Health and Production in the quarantine guidance document.

# Article 20. Order, procedures and contents of quarantine of animals and animal products brought in and taken out the bonded warehouses

- 1. Quarantine registration
- a) Before importing or exporting animals and animal products from bonded warehouses, the owner of the goods shall send 01 quarantine registration dosiers as prescribed in Clause 2, Article 18 of this Circular to the Department of Animal Health and Production in one of the following methods: via the National Single Window or via public postal service or via email, fax, then send the original or send directly;
- b) The Department of Animal Health and Production shall implement in arcording to the Point b, Clause 1, Article 11 of this Circular.
  - 2. Quarantine declaration
- a) After the Department of Animal Health and Production has a written consent and quarantine instructions, before the goods arrive at the import border gate, the owner of the goods shall send 01 quarantine declaration dosiers specified in Clause 4, Article 18 of this Circular to the animal quarantine agencies at the border gate in one of the following methods: via the National Single Window or via the public postal service or via email, fax, then send the original or directly sending;
- b) The border gate quarantine agency shall implement in according to the Point b, Clause 2, Article 11 of this Circular.

3. Quarantine contents of goods brought in bonded warehouses

The animal quarantine agencies at the border gate implement quarantine goods imported into bonded warehouses as follows:

- a) According to the provisions at Points a, c, d and dd, Clause 1, Article 50 of the Law on Veterinary Medicine;
- b) Notify the owner of the goods (Form 14b) so that the owner of the goods can transport the goods from the import border gate to the bonded warehouse;
- c) At the bonded warehouse, the border quarantine agency coordinates with the customs agency to inspect the actual status of the shipment and confirms that the owner can import the goods into the bonded warehouse.
  - 4. Contents of quarantine of goods taken out the bonded warehouse

The border animal quarantine agencies shall implement quarantine goods taken out the bonded warehouse as follows:

- a) Implement according to the provisions of Article 12 of this Circular for animal products consumed domestically;
- b) Implement according to the provisions of Article 16 of this Circular for animal products for processing and manufacturing of export goods;
- c) Implement according to the provisions of Article 50 of the Law on Veterinary Medicine for animal products sent to the bonded warehouse for export to other countries or foreign cruise ships, the Health Certificate is issued according to Form 16b of Appendix V issued along with this Circular;
- d) In case of consignments are taken out of bonded warehouses partially, the border animal quarantine agencies shall deduct the quantity of goods in the original quarantine certificate of the exporting country, keep a copy of quarantine certificate in quarantine dossier; for the original quarantine certificate of the exporting country, the border animal quarantine agencies will keep back and save it in the last shipment of the consignment (in case of import for domestic consumption, as raw materials for export production) or handed over to the owner of the goods (in case of re-exported goods).

#### Section 5

QUARANTINE TERRESTRIAL ANIMALS PARTICIPATING IN FAIRS, EXHIBITIONS, ART PERFORMANCES, SPORTS COMPETITIONS; TERRESTRIAL ANIMAL PRODUCTS PARTICIPATING IN FAIRS, EXHIBITIONS; SENDING AND RECEIVING DISEASE PRODUCTS

Article 21. Quarantine of terrestrial animals participating in fairs, exhibitions, sport competitions, art performances; terrestrial animal products participating in fairs, exhibitions

Implemented in accordance with the provisions of Article 51 of the Law on Veterinary Medicine.

### Article 22. Transportation of animal disease specimens

Comply with the provisions of Article 52 of the Veterinary Law and use Form 5 of Appendix V issued with this Circular.

# Section 6 FORM OF QUARANTINE DOSSIERS FOR ANIMALS AND ANIMAL PRODUCTS

# Article 23. Form of quarantine dossiers for animals and animal products

- 1. Form of quarantine dossier for animals and animal products; quarantine dossier and concurrent state inspection of food safety as prescribed in Appendix V issued with this Circular.
  - 2. The dossier form is used uniformly nationwide.
- 3. Animal quarantine agencies are responsible for printing and using the quarantine dossier form in accordance with current regulations.
- 4. Organizations and individuals printing, publishing and using profile forms contrary to the provisions of this Circular shall be responsible before the law.

# Article 24. Management, use forms of Health Certificate for animal and animal products

- 1. The forms of quarantine certificate for animals and animal products are printed in black ink on paper A4, the animal quarantine logo watermarked in the middle, light black, 12 cm diameter.
- 2. Quarantine certificate for animals, animal products shipped out of province-level localities must be stamped "ORIGINAL" or "COPY" in red ink in the lower right corner of the "Form: ..." (Form of stamp as prescribed in Annex VI issued along with this Circular). The number of quarantine certificates issued as bellows:
- a) Original: 01 kept at the animal quarantine agency, 01 delivered to the goods owners;
- b) Copy: Based on the place of delivery in the transport process (if any) to issue maximum 03 copies to the goods owners, each delivery place is only granted 01 copy; the copies use red seal of the competent veterinary authority that issued the original.

In case of authorization, use the template of quarantine certificate for animals and animal products shipped out of province-level localities as Form 12b and 12d Annex V issued along with this Circular.

- c) The electronic Health Certificate issued through the public service portal has the same value as the original.
- 3. Quarantine certificate for animals, animal products exported, imported, temporary imported for re-export, temporary exported for re-import, border-gate transfer and transit the Vietnamese territory must be stamped "ORIGINAL" or "COPY" in red ink in the lower right corner of the "Form: ..." (Form of stamp as prescribed in Annex VI issued along with this Circular). The number of quarantine certificates issued as bellow:
- a) Quarantine certificate for animals, animal products exported, imported: 03 Original (01 kept at the animal quarantine agency, 02 delivered to the goods owners); 02 Copy for goods owners;
- b) Quarantine certificate for animals, animal products temporary imported for re-export, temporary exported for re-import, border-gate transfer and transit the Vietnamese territory: 03 Original (01 kept at the animal quarantine agency, 02 delivered to the goods owners); 02 Copies delivered to the good owners in which 01 Copy is returned to the Border animal quarantine agencies after the shipment is re-exported from the territory of Vietnam and certified by the Border animal quarantine agency at export gate); All Copy used red seal of the competent veterinary authority that issued the original.
- 4. Transportation certificate for imported animals and animal products is issued 03 copies (01 copy kept at the border animal quarantine agency at imported gate, 02 copies delivered to the goods owners).
- 5. The period of validity of the quarantine certificate for animals and animal products:
- a) The period of validity of the quarantine certificate for animals and animal products shipped out of province-level localities is the transport time of animals and animal products from the place of origin to final destination;
- b) The period of validity of the quarantine certificate for animals and animal products imported is 60 days, exported is 180 days;
- c) The period of validity of the quarantine certificate for animals and animal products temporarily imported for re-export and border-gate transfer and transit of Vietnam's territory shall be calculated according to the maximum time allowed to stay in the territory of Vietnam.

### **Chapter III**

MARKING AND ISSUING ANIMAL CODE, SEALING MEANS OF TRANSPORTATION AND ITEMS CONTAINING ANIMALS AND ANIMAL PRODUCTS SUBJECT TO QUARANTINE

# Article 25. General provisions on marking, issuing animal code; sealing means of transportation, items containing animals and animal products

- 1. Types of animals that must be marked and issued with codes:
- a) Breeding animals (buffalo, cow, goat, sheep, deer, horse, donkey, mule and pig) when transported out of the provincial level localities;
- b) Animals (buffalo, cow, goat, sheep, deer, horse, donkey, mule and pig) when exporting and importing.
- 2. Code of agencies having professional veterinary and production management function at provincial level as defined in Annex VIIa issued together with this Circular.
- 3. Code of the border animal quarantine agencies under the Department of Animal Health and Production as prescribed in Appendix VIIb issued along with this Circular.
- 4. Agencies having professional veterinary and production management function at provincial level shall specify codes for each commune, towns and special zones (hereinafter referred to as commune) and notify the codes to the Department of Animal Health and Production and the Agencies having professional veterinary and production management function nationwide.
- 5. The Department of Animal Health and Production will complement codes to the border animal quarantine agencies belong to the Department of Animal Health and Production and Agencies having professional veterinary and production management function at provincial level newly formed.
- 6. Sealing means of transportation, items containing animals and animal products: Under the provisions of Annex VIIc issued together with this Circular.

### Article 26. Marking animals shipped out of province-level localities

- 1. Breeding animals (buffalo, cow, goat, sheep, deer, horse, donkey, mule) when transported out of the provincial level localities must be marked by ear tagging. Ear tags are regulated as follows:
- a) Blue ear tags as shown in Figure 1 of Appendix VIII issued with this Circular, size 4cm (width) x 5cm (height); the tag must clearly state the code and identification number of the livestock;
- b) Animal code includes: Code of the agencies having professional veterinary management function at provincial level; commune code (three digits); year of piercing the ear tags (last two digits of the year) and the serial number of the animals (calculated from 000001 to 999999).

Write codes of animals on ear tags as Figure 2 Annex VIII issued along with

this Circular;

- c) Ink to write animal codes on ear tags is black; does not smudge, difficult to erase.
- 2. Breeding pigs when being transported shall be marked using one of the following methods:
  - a) Ear tagging as prescribed in Clause 1 of this Article;
- b) Tattooing the province code, commune code and year code on the outside, below the right ear of the pig. Tattooing the code on the skin on the outside, below the pig's ear is regulated as follows:

The shape, size of the digits: The digits used for tattooing on the pig's ear may use the digits in Figure 1a or Figure 1b in Appendix VIII issued with this Circular; the tattoo needles of the digits are 6 mm high (calculated from the surface of the tattoo table) and pointed at the tip; the digits are 4 - 8 mm wide and 8 - 12 mm high respectively;

The tattoo code on the pig's ear (according to Figure 2a or Figure 2b in Appendix VIII issued with this Circular) is specified as follows: The first 2 (two) digits are the code of the provincial veterinary management agency; the next 3 (three) digits are the code of the commune (where the pig originates or where it is isolated for quarantine) and the last 2 (two) digits are the last 2 (two) digits of the year in which the tattoo code is performed;

- c) Ink used to tattoo codes on the pig skin must be ensured food safety, is not discolored.
- 3. Pigs transported to slaughterhouses must be sealed with lead clamps or sealing ropes with codes and serial numbers.
- 4. Livestock that have been marked according to the provisions of Clause 1 and Clause 2 of this Article do not need to be re-marked when quarantined and transported for consumption if the code and serial number of the livestock do not lose color.
- 5. After quarantine, if livestock meets veterinary hygiene requirements, the animal quarantine agencies shall make a list of codes and identification numbers of livestock (according to the form in Appendix IX issued with this Circular) and send along with it the Health Certificate.

### Article 27. Marking of exported and imported livestock

- 1. Exported and imported animals must be marked by stamping rubber ear tags on the inside of the right ear of the animals.
- 2. The yellow ear tag has the shape shown in Figure 3 in Appendix VIII issued with this Circular; the ear tag must clearly state the code and identification number of the animals.

- 3. The code and identification number of animals includes: Code of the border animal quarantine agencies under the Department of Animal Health and Production; code of the province (where animal is quarantined for export and import quarantine or place of departure for exported livestock); year of issuance of the ear tag and identification number of the livestock.
- 4. Ink to write the code and identification number of animal on the ear tag according to the provisions of Point c, Clause 1, Article 26 of this Circular.
- 5. The way to write the code and identification number of animal on the ear tag (Figure 4, Appendix VIII, issued with this Circular) is specifically regulated as follows:
- a) The top row includes: The code of the animal quarantine agencies for import and export; The next 02 (two) digits are the code of the province (where livestock is quarantined for export and import quarantine or the place of departure for exported livestock); The last 02 (two) digits are the last 02 (two) digits of the year the ear tag was issued;

In case imported animals does not have to be quarantined, use the code of the province where the border gate is located to carry out animal import quarantine procedures;

- b) The bottom row is the livestock's identification number (calculated from 000001 to 999999).
- 6. After quarantine, if animals meet the requirements of veterinary hygiene, the animal quarantine agency will list the codes, identification number of the animals (as form in Annex IX issued along with this Circular) and enclose certificate of animal quarantine.
- 7. In case the imported cattle have already been marked or issued with ear tags, the provisions in Clauses 1, 2, 3, 4 and 5 of this Article are not required. The border animal quarantine agency shall prepare a list of codes and IDs of imported cattle according to the provisions under Clause 6 of this Article (except in cases where there is an existing list of codes and IDs of cattle attached to the quarantine certificate of the exporting country)."

# Chapter IV IMPLEMENTATION

### Article 28. Responsibilities by related organizations, individuals

- 1. Responsibilities of the Department of Animal Health and Production:
- a) Guide the animal quarantine agencies implementing the quarantine of animals and animal products as prescribed in this Circular;
- b) Guide organizations and individuals to carry out the quarantine of animals and animal products imported;

- c) Guide printing, using forms of animal quarantine records, animal products;
- d) Guiding on standards, organizing trainings, issuing animal quarantine cards for officers who are authorized to perform the quarantine and issue quarantine certification of animals and animal products shipped out provincial-level localities;
- đ) Chairing to organize the implementation as prescribed in clause 1 and clause 2 of Article 59 of the Veterinary Law;
- e) Periodically and irregularly inspect the domestic animal quarantine agencies, quarantine officers authorized to quarantine and issue quarantine certification of animals and animal products shipped out of province-level localities;
- g) Public the list of establishments has been recognized as disease free in nationwide
- 2. Responsibilities of animal quarantine agencies at border gates under the Department of Animal Health and Production:
- a) Organizing quarantine and issuing quarantine certificate of animals and animal products for export, import, temporary import for re-export, temporarily export for re-import, transfer gate, bonded warehouses and transit via the territory of Vietnam as prescribed in this Circular;
- b) The establishments of slaughtering, pre-processing, processing of animal products for export purpose shall be inspected and monitored by the border animal quarantine agencies. If the establishments produce for domestic consumption or for export to countries without export quarantine requirements, the border animal quarantine agencies managing those establishments will issue quarantine certificate under the provisions on quarantine of animal products shipped out of province-level localities.
- 3. Responsibilities of the agencies with the specialized management function of Animal Health and Production at the provincial level:
- a) Implementing quarantine of animals and animal products shipped out of province-level localities under the provisions of this Circular and the guidance of the Department of Animal Health;
- b) Coordinate with the border animal quarantine agencies of the Department of Animal Health to check veterinary hygiene conditions of isolation place for quarantine imported animals;
- c) Organizing quarantine of animals and animal products for export, import, temporary import for re-export, temporarily export for re-import, transfer gate, bonded warehouses and transit via the territory of Vietnam as prescribed in this

Circular at the authorized border gates;

- d) Authorizing for animal quarantine officers conducting quarantine and issuing quarantine certificate for animals and animal products shipped out of the province in accordance with the law;
- d) Responsible for the authorization and regularly guide, inspect and supervise the quarantine and issuing quarantine certificate of the personnel being authorized;
- e) Notify the related agencies and departments list of officers being authorized to carry out quarantine and issuing quarantine certificate of animals and animal products;
- g) Publish and report to the Department of Animal Health list of establishments in the province, city having implemented disease surveillance, disease prevention by vaccine and still in the immune protection period; disease free establishments; the pre-processing and processing facilities being supervised veterinary hygiene.
  - 4. Responsibilities of the goods owners:
- a) Comply the provisions of the legislation on veterinary and other relevant legislation in the quarantine of animals and animal products;
- b) Paying the cost of quarantine and testing; actual costs for the handling and disposal of unsatisfactory shipments (if any) in accordance with current regulations.
- c) In case of sending paper documents, the document components require copies, the copies only need to be signed and stamped by the cargo owner;
- d) Be fully responsible before the law for the legality and accuracy of the registration and quarantine declaration documents.
- d) The goods owner is responsible for arranging a quarantine location for imported animals and animal products to ensure veterinary hygiene requirements according to regulations;
- e) The goods owner is responsible for arranging a warehouse to ensure the requirements for preserving goods.

## **Article 29. Transitional provisions**

Types of printed forms of Health Certificate for animals and animal products transported out of the provincial - level localities as prescribed in Circular No. 25/2016/TT-BNNPTNT dated June 30, 2016 of the Minister of Agriculture and Rural Development regulating the quarantine of animals and terrestrial animal products are allowed to be used until June 30, 2026.

### Article 30. Implementation validity

- 1. This Circular takes effect from January 1, 2026.
- 2. This Circular replaces the following documents:
- a) Circular No. 25/2016/TT-BNNPTNT dated June 30, 2016 of the Minister of Agriculture and Rural Development regulating the quarantine of animals and terrestrial animal products;
- b) Circular No. 35/2018/TT-BNNPTNT dated December 25, 2018 of the Minister of Agriculture and Rural Development amending and supplementing a number of articles of Circular No. 25/2016/TT-BNNPTNT dated June 30, 2016 and Circular No. 20/2017/TT-BNNPTNT dated November 10, 2017 of the Minister of Agriculture and Rural Development;
- c) Circular No. 09/2022/TT-BNNPTNT dated August 19, 2022 of the Minister of Agriculture and Rural Development amending and supplementing a number of articles of the Circulars regulating the quarantine of terrestrial animals and animal products;
- d) Circular No. 04/2024/TT-BNNPTNT dated April 1, 2024 of the Minister of Agriculture and Rural Development amending and supplementing a number of articles of the Circulars regulating the quarantine of terrestrial animals and animal products;
- d) Circular No. 28/2025/TT-BNNMT dated June 24, 2025 of the Minister of Agriculture and Environment amending and supplementing a number of articles of Circular No. 25/2016/TT-BNNPTNT dated June 30, 2016 of the Minister of Agriculture and Rural Development regulating the quarantine of terrestrial animals and animal products.
- 3. Nullify the Article 22 of Circular No. 09/2025/TT-BNNMT dated June 19, 2025 of the Minister of Agriculture and Environment regulating decentralization, delegation and assignment of authority in the field of state management of veterinary animal husbandry.
- 4. In the course of implementation, if there are any problems, organizations and individuals are requested to report to the Ministry of Agriculture and Environment for consideration and decision./.

#### I. ANIMAL

- 1. Livestock: Buffalo, cattle, donkeys, horses, mules, goats, sheep, pigs, rabbits, dogs, cats and other domestic livestock species.
- 2. Poultry: Chickens, ducks, muscovy, geese, turkeys, ostriches, pigeons, quails, ornamental birds and other bird species.
- 3. Experimental animals: Guinea pigs, white tiny mice, rabbits and other laboratory animals.
- 4. Wildlife animals: elephants, tigers, leopards, bears, deer, gibbons, orangutans, monkeys, pangolins, lorises, squirrels, raccoons, lizards, geckos, pythons, snakes, jungle fowl, pheasants, peacocks and other wildlife animal species.
  - 5. The other animals: bee, silkworm, and other insects.

#### II. ANIMAL PRODUCTS

- 1. Meat, products derived from meat, offal, by-products of terrestrial animals origin.
- 2. Polony, pate, sausage, ham, lard and other animal products in the form of preliminary processing and processing.
  - 3. Milk and dairy products.
  - 4. Eggs and egg products of terrestrial animals.
  - 5. Hatching eggs, silkworm eggs; embryos, semen of animals.
- 6. Meat meal, bone meal, blood meal, feather meal and other animal products used as raw materials; feed of animals, poultry and aquatic animals containing ingredients of animal origin;
- 7. Fish meal, fish oil, fish fat, shrimp powder, oyster powder and other aquatic products used as raw materials for processing feed for livestock, poultry and aquaculture.
- 8. Pharmaceutical materials of animal origin: Snake venom, bee venom, pangolin scales, bear bile, bone glue, digestive enzymes and other pharmaceutical materials of animal origin
  - 9. Animal skin in the form of: Fresh, dried, salted.
  - 10. Fur, stuffed animals of tiger, panther, mongoose, rabbits, and other

#### animals.

- 11. Cilia: horsehair, feathers oxtail, pig hair, wool and feathers of other animal species.
- 12. Feathers: chicken feathers, duck feathers, goose feathers, peacock feathers and feathers of other birds.
  - 13. Teeth, horns, nails, tusks, bones of animals.
  - 14. Bird nests, bird nest products.
  - 15. Honey, royal jelly, beeswax.
- 16. Other subjects to animals and animal products quarantine as required by the importing countries or the provisions of the international treaties to which Vietnam has signed or acceded to.





#### 2. Regulations on periodic monitoring:

a) For husbandry establishments have not recognized as disease free, have not periodically surveillance as regulations or have not been vaccinated by vaccines or have been vaccinated but no longer immune protection: Periodically sampling every 6 months; for collecting facilities and business facilities: Periodically sampling every 3 months.

In case the owner does not perform periodic monitoring, the domestic animal quarantine agencies shall take samples to check criteria for each shipment.

- b) The number of samples collected for surveillance as the disease prevalence estimated at 10% according to the guidelines in Table 2 of this Annex.
- c) Based on the results of periodic monitoring of pathogens and clinical examination of animals before transporting the animals out of the provincial-level localities, if animals are healthy and not carriers of the pathogens, the domestic animal quarantine agencies issue health certificate for transport of animals or animal products out of the provincial-level localities.

#### 3. Samples for testing

- a) Diseases that must be tested for animals transported out of the provincial-level localities specified in Clause 1 of this Part: The test sample is a sample combined from 05 single samples into 01 sample to test for pathogens;
- b) Principle of combining test samples: only combine single samples of the same animal species, same shipment, same animal breeding or collection and trading facility;
- c) In case it is not possible to combine samples for testing according to the combined sample, test for pathogens according to the single sample.

#### II. Animal products:

Animal products used as food: Meat and meat products of animal and poultry in fresh, chilled, frozen, and primery processed forms.

Checking pollutant microorganisms: Monthly sampling and testing according to national technical standards and regulations for pollution limits of microorganisms in food.

#### 2. Sampling for testing

Sampling for testing for pathogens specified in Section 1 of this Appendix for imported animals is carried out as follows:

a) Sampling for testing for pathogens specified in Section 1 of this Appendix for imported animals according to the predicted disease prevalence rate of 5% according to Section 3 of this Appendix.

Based on the recognition of the disease status of the exporting country by the World Organization for Animal Health (WOAH), the content of the quarantine certificate of the competent authority of the exporting country; sampling for testing and inspection of pathogens as specified in Section 1 of this Appendix for imported animals is carried out according to the instructions in Points b and c of this Section.

- b) Do not take samples for disease testing for:
- b1) Animals originated from countries and territories that have been recognized by the World Organization for Animal Health (WOAH) as disease-free for the diseases specified in Section 1 of this Appendix.
- b2) Diseases specified in Section 1 of this Appendix have been certified by the competent authority of the exporting country in the Export Health Certificate as disease-free or the animals have been vaccinated.
- c) Diseases specified in Section 1 of this Appendix have been tested and certified by the competent authority of the exporting country in the Export Health Certificate, samples are taken based on the predicted disease prevalence rate of 10% according to Section 3 of this Appendix.
- d) Based on the disease situation of the exporting country, the Department of Animal Hralth and Production shall provide guidance on the disease indicators that need to be tested for quarantine.
- đ) In case of detecting a new disease that is not specified in Section I of this Appendix, the Department of Animal Husbandry and Veterinary Medicine shall report to the Ministry of Agriculture and Environment for consideration and decision on the quarantine indicators for the new disease.

e) Based on clinical symptoms, the animal quarantine agency at the border gate shall take samples for testing to check for pathogens according to the provisions of Appendix III.

#### b) Sampling for testing

#### b1) For high – risk animal products:

Sampling each batch of goods for inspection and testing of pathogenic agent indicators according to the provisions in Point a of this Clause.

Do not take samples for testing of pathogenic agents for animal products in the high-risk category originated from countries and territories that have been recognized by the World Organization for Animal Health (WOAH) as diseasefree for the diseases prescribed in Point a of this Clause.

Particularly for the indicators of *Salmonella spp.*, *E.coli (type* O157:H7), sampling is performed at the following frequency: Sampling 03 consecutive consignments of goods for inspection and testing. If the inspection and testing results of 03 consecutive consignments of goods meet the requirements, only 01

random consignment of goods shall be sampled for inspection and testing for every 03 subsequent consignment of goods. In case anunsatisfactory consignment is detected, sampling of the next 03 consecutive consignments of goods shall be applied for inspection and testing.

The animal quarantine agency at border-gate shall take samples at border-gates, inspect the actual status of goods and issue Notification (Form 14b) to the goods owner for transportation of the goods to warehouse at the request of the goods owner; The goods owner must be responsible for transporting and preserving goods while pending for quarantine. In case the goods of animal products cannot be sampled at border-gate, the quarantine agency at border-gate shall take samples for quarantine at preservation warehouse.

Particularly for frozen animal products, it must be kept at border-gate area until satisfactory inspection results are obtained.

#### b) For low-risk animal products:

To take samples for inspection and testing of indicators as prescribed at Point a, this Clause. Frequency of sampling is as follows:

For every 05 consignments of goods, 01 random consignment of goods shall be sampled for inspection and testing; if an unsatisfactory consignment is detected, 03 consecutive consignments of goods shall be sampled for inspection; if the inspection and testing results of 03 consecutive consignments of goods meet the requirements, only 01 random consignment of goods shall be sampled for inspection and testing for every 05 consignment of goods.

Do not take samples for testing of pathogens for low-risk animal products originated from countries and territories recognized by the World Organization for Animal Health (WOAH) as disease-free for the diseases specified in Point a of this Clause.

The taking samples for quarantine and the inspection of the actual status of goods shall be carried out at the border-gate or warehouses of the goods owner meeting the requirements (if so requested by the goods owner); The goods owner must be responsible for transporting and preserving goods while pending for quarantine.

Consignments of goods that are not required to be sampled for inspection, testing: within one working day, the animal quarantine agency at the border gate shall inspect the dossiers and the actual status of the goods. If the requirements are met, import health certificate shall be issued. The goods owner shall be responsible for imported goods.

# 2. Animal feed and raw materials production of animal feed of animal origin imported:

#### a) Pathogen to be tested

- b) Sampling for testing
- b1) For complete mixed feed, concentrated feed, supplementary feed, finished aquatic feed, sampling is performed at the frequency as follows:

For every 05 consignments of goods, 01 random consignment of goods shall be sampled for inspection and testing; if an unsatisfactory consignment is detected, 03 consecutive consignments of goods shall be sampled for inspection; if the inspection and testing results of 03 consecutive consignments of goods meet the requirements, only 01 random consignment of goods shall be sampled for inspection and testing for every 05 consignment of goods.

- b2) For raw materials of animal origin for the production of animal feed and aquatic feed: take samples from each consignments of goods to test for pathogens specified in Point a of this Clause.
- b3) For feed and raw materials specified in points b1 and b2 of this clause containing many components from products of different animal species, no more than 02 pathogenic agent indicators shall be tested according to the provisions in point a of this clause.
- b4) Sampling and testing of pathogens shall be applied according to the regulations, standards, technical regulations of Vietnam and international regulations.
- c) Sampling for ruminant DNA testing of terrestrial and aquatic animal protein powder for the production of animal feed and aquatic feed:
- c1) For products originate from countries and territories recognized by the World Organization for Animal Health (WOAH) as having a negligible risk of Mad Cow Disease (BSE) according to the WOAH Resolution: randomly sample 01 random consignment of goods from every 05 consignments of goods for testing.
- c2) For products originate from countries and territories not covered by the provisions of point c1: randomly sample 01 random consignment of goods from every 03 consignments of goods for testing.
- d) For animal products that do not require ruminant DNA testing, in case the owner requests to bring the goods to the storage for preservation (the owner's storage must ensure the conditions for storing the goods), the animal quarantine

agency at the border gate shall take samples at the border gate, check the actual condition of the goods, issue a Notification (Form 14b) for the owner to transport the goods to the storage or the sampling can be done at the storage; the owner must be responsible for transporting and preserving the goods and must not sell the goods when the consignent of goods does not have satisfactory quarantine results;

- e) For raw materials for animal and aquatic feed that must be tested for ruminant DNA must be kept at the border gate area until the test results meet the requirements.
- g) In case the consignent of goods does not require sampling within 01 working day, the animal quarantine agency at the border gate will only check the documents, and if the requirements are met, an Import Health Certificate will be issued. The owner of the goods must be responsible for the imported goods.

#### 3. Animal products not used as food:

Based on the provisions in , Clause 1, Clause 2, Section II of this Appendix, conduct sampling to test for pathogens with the corresponding category/type products.

In case the consignent of goods does not require sampling within 01 working day, the animal quarantine agency at the border gate will only check the documents, if the requirements are met, the Import Health Certificate will be issued. The owner of the goods must be responsible for the imported goods.

- 4. In addition to the pathogens specified in Clause 1, Section I, Point a, Clause 1, Section II, Point a, Clause 2, Section II of this Appendix, based on the development of the epidemic, the Department of Animal Health and Production decide the disease indicators for testing according to the regulations and recommendations of the World Organization for Animal Health (WOAH).
- 5. Frequency sampling is applied to the total number of imported consignent of goods from January 1 to December 31 in the same year.

# III. Quarantine contents for imported terrestrial animal products used as raw materials for processing and re-export are as follows:

- 1. Check the quarantine dosiers and the contents of the Health Certificate issued by the competent veterinary authority of the exporting country for the consigment of goods.
  - 2. Check the actual condition of the goods.
  - 3. Take samples to test for pathogens as follows:
- a) For chicken meat, duck meat, goose meat, goose meat and edible byproducts after slaughter of chicken, duck, goose, and geese: Take samples to test for pathogens of Highly Pathogenic Avian Influenza; Newcastle.

- b) For pork and edible by-products after slaughter of pigs: Take samples to test for pathogens of Mouth-and-Mouth; African Swine Fever (for countries and territories with epidemics);
- c) For buffalo, cattle, goat, sheep meat and edible by-products after slaughter of buffalo, cattle, goat, sheep: Take samples to test for pathogens of Brucellosis and foot-and-mouth disease.
- 4. The frequency of sampling to test the pathogen indicators is as follows: For every 06 consigment of goods, take 03 samples of 01 consigment of goods for inspection.
- 5. In case the consignment of goods are subject to inspection of only quarantine dosiers, the contents of the Health Certificate, and the actual condition of the goods: If the actual condition of the goods is found to not meet veterinary hygiene requirements, consignment of goods will be taken samples to check the veterinary hygiene indicators.
- 6. Handling of inspection results: To be carried out in accordance with current legal regulations.

Based on the animal disease situation of the exporting country, the risk factors that need to be controlled according to regulations, the Department of Animal Health and Production will guide the adjustment and supplementation of inspection indicators.

#### IV. Principles of sampling and pooling samples for testing

- 1. Pathogens for imported animals as prescribed in Section 1, Part I of this Appendix: combine 05 single samples into 01 sample for testing.
  - 2. For imported animal products as prescribed in Part II of this Appendix:
- a) A consignment of goods with 01 to 02 items: sample all items; each item takes 05 single samples and combines them into 01 sample for testing;
- b) A consignment of goods with 03 or more items: sample the 03 items with the largest quantity/volume; each item takes 05 single samples and combines them into 01 sample for testing.
- 3. Principles of combining test samples: only combine single samples of the same species, same animal, same consignment of goods, same country, same territory.
- 4. In case it is not possible to pool samples for testing according to pooled samples, test for pathogens according to single samples.
- 5. When detecting imported animal product consignment that do not meet sensory requirements, take samples to test for physical and chemical indicators, harmful microorganisms, and pathogens according to the relevant regulations,

standards, and norms of Vietnam and international regulations.

#### **Annex XIII**

# CONTROL ON STORAGE, TRANSPORTATION, TRADE AND CONSUMPTION OF ANIMAL PRODUCTS AFTER IMPORTATION FOR FOOD

(Issued along with Circular No /2025/TT-BNNMT ...../2025 by the Minister of Agriculture and Environment)

1. Requirements on veterinary hygiene, food safety in preservation, subdivision, repackage animal products after importation for food:

Follow Chapter IV of the Veterinary Law and Food Safety Law.

- 2. Control of movement and trading imported animal products
- a) For imported consignments after being granted the health certification for import by the import animal quarantine agencies, then subdivided, repackage for transportation to other provinces, the local animal quarantine agencies comply with the provisions of clause 2, Article 39 of the Veterinary Law;
- b) In case when subdividing, repackaging detect the imported animal products does not meet the veterinary hygiene requirements or detect the preservation condition of animal products is not satisfactory, the domestic animal quarantine agencies organize sampling and testing; if the tests meet requirements, issue the health certificate for transport; if not meet the requirements shall handle according to regulations or change use purposes (use for animal feed, fed to crocodiles), the local animal quarantine agencies inform the local animal quarantine agencies of destination to continue monitor.

#### **APPENDIX:**

### APPENDIX XIV: PROCEDURE FOR INSPECTION AND SAMPLE COLLECTION FOR OUARANTINE SHIPMENTS OF TERRESTRIAL ANIMAL PRODUCTS

(Issued together with Circular No. ..../2025/TT-BNNMT dated..../2025 by the Minister of Agriculture and Environment)

#### I. GENERAL PROVISIONS

#### 1. Definitions

- **Packaged unit:** means independent packaging in the form of bags, bales, barrels, boxes, bottles, jars, etc. repeatedly used in a consignment.
  - **Sample:** means a representative portion of a shipment.
- **Sampling:** means technical operations conducted on the basis of prescribed principles, procedures and technical conditions to collect samples representative of the shipment, indicative of the actual condition of the shipment.
- Single sample (primary sample): means a certain quantity of product or packaged unit collected individually, randomly or intentionally, at the same time within a location in the shipment.

**Pooled sample (bulk sample)**: consists of single samples from the same shipment combined together so that representative characteristics of the shipment can be obtained.

- Analytical sample (testing sample): part of a pooled sample, used to evaluate the quality of a specified shipment.
- **Storage sample**: means a sample taken from a pooled sample. In case of failure to pool, a single sample is stored.
- **Representative sample**: means certain products of the bulk sample or certain packaged units taken from the bulk sample.

#### 2. General principles

- Before sample collection, documents related to a shipment must be reviewed; the current status of products must be checked and, if applicable requirements are met, samples will be collected.
- In order for samples to accurately reflect the overall condition of a consignment, the material of the consignment must be uniform.
- Sampling must be science-based, simple and convenient; the sampling process must be public and transparent; Ensure random selection of samples at different locations for best representation of a consignment.
- In case it is not possible to obtain samples at the border gate, then collect animal products for sampling at an animal quarantine agency or the enterprise's warehouse.
- Samples must be tested at a laboratory under the animal health and production agency, registered for testing activities according to Decree No.

107/2016/ND-CP dated July 1, 2016 of the Government regulating business conditions for conformity assessment services (the testing field is related to animal disease testing indicators.

#### II. IMPLEMENTATION PROCESS

#### 1. Preparation

- Before sampling, the inspection and sampling time shall be agreed upon with the consignor or representative.
- Relevant documents, forms, tools and equipment must be prepared for sampling and proper sample preservation must be in place.

#### 2. Physical examination

- 2.1. Examine veterinary hygiene conditions of transport vehicles, containers, and seals.
- 2.2. Examination of consignments: storage conditions, packaging specifications, product appearance, product types and labels, and detailed information of consignments that must be consistent with accompanying documents.

Each item is examined for a minimum of 5 randomly selected locations or packaged units at different locations of the consignment. In case a consignment contains different items, examine and collect samples of a maximum of 03 items with the largest quantity/volume.

For a consignment with multiple containers and wagons: the sampling staff randomly selects and conducts inspection on 02 to 04 containers, carts (not applicable to shipments subject to DNA testing). In case of uncertainty, the entire shipment can be inspected.

Result processing and handling: Check the actual status of products and take samples for quarantine, if applicable requirements are met, or otherwise handle products as prescribed.

#### 3. Sampling

- 3.1. Quantity and volume of samples:
- 3.1.1. The quantity of samples required for disease testing is stipulated in Section IV and Section V, Appendix XII attached to this Circular.
  - 3.1.2. The quantity of samples for DNA testing is as follows:
  - From 01 to 05 containers: obtain 01 sample
  - From 06 to 10 containers: obtain 02 sample
- For a consignment with more than 10 containers, 01 more sample required for additional 01-05 containers

In case a consignment is stored in a cargo hold or train wagons: Collect 01 sample if the quantity is  $\leq 200$  tons, 2 samples if the quantity is from 200 to 500 tons and 3 samples if the quantity is over 500 tons.

- 3.1.3. Size of analytical sample (laboratory sample), storage sample: The minimum volume of samples must be adequate for analysis according to regulations and the laboratory's analysis method. In case samples must be sent to multiple laboratories, additional samples should be collected accordingly. The volume of the average sample, or primary sample (in case the primary sample is equivalent to the average sample) is from 500 1000g (excluding bones).
  - 3.2. Sampling for analysis
  - 3.2.1. Collection of primary samples
  - a) With packaged consignments
- Shipment with packages in the form of bags, bales, boxes, barrels, etc.: the primary sample is obtained from at least 01 packaged unit but not more than 05 packaged units through a random selection of products from the selected packages, except in the case of small packaged units, then additional samples must be obtained to ensure sufficient testing volume, based on the testing methodology.
- Liquid and viscous products: Single samples are obtained at a minimum of 03 spots at different depths within the packaged unit.
- b) For bulk consignments (contained in wagons, containers, cargo holds, etc.): Primary samples shall be taken at at least 03 different locations of the consignment.
  - 3.2.2. Preparation of bulked sample

Mix all the primary samples taken to form a bulk sample that represents the consignment.

- 3.2.3. Preparation of representative sample
- a) Liquid and viscous products: Thoroughly mix the bulk sample and withdraw a portion to create a representative sample;
- b) Products in the form of fibers, pieces, and small pellets can be sampled using the random sampling method;
- c) Large size products can be randomly selected (cut into small pieces if necessary);
- d) Pre-packaged products: Packages can be thoroughly mixed, before random selection of products;
- đ) Size of representative samples should be sufficient to analyze indicators and store samples and store samples.
  - 3.2.4. Preparation of the final samples (analytical samples)

The representative sample should be divided into 2 corresponding parts, 1 being the analytical samples and the other being the storage samples sharing the same quantity/volume. The size of samples taken should be sufficient for testing and storage depending on the testing method. In case it is necessary to send sample to more than one laboratory, the final sample can be subdivided for separate

analysis. If the testing methodology only requires a small sample volume, after ensuring the test sample is representative of the shipment, extra sample shall be returned to the consignor.

- 3.2.5. Labeling, packaging, sealing, preservation and transportation of samples
- a) Samples must be packaged, sealed, and labeled to ensure confidentiality and avoid confusion;
- b) Sample preservation: Samples are preserved under conditions suitable for each type of product in their original state.

#### 3.2.6. Sampling records

The sampling record is made according to form 06, Appendix V issued with this Circular, and is created immediately after sampling, under the witness and signature of the consignor and relevant parties.

The information in the Sampling Record shall be documented in full and accurately, reflecting truthfully condition of the shipment such as packaging, storage, date of manufacture, expiry date, note of the means of transport, container, seal number.

#### 3.2.7. Delivery of samples

- a) Samples must be delivered to the laboratory as quickly as possible using means of transport in a way that does not affect the quality of samples;
- b) Samples sent to the laboratory must be coded. Sample containers sent to the laboratory must be sealed and protected from the effects of sunlight and temperature to avoid adverse impacts on the sample quality.

#### 3.2.8. Storage and destruction of samples

Samples are stored for 30 days in conditions appropriate to each type of product. The volume of stored sample is consistent with the testing methodology.

At the end of the storage period, the stored sample must be disposed of in accordance with provisions of law.

#### 3.2.9. Returning excess animal products after sampling

The return of extra samples (not used for testing) is done after obtaining satisfactory test results (Extra Sample Return Form can be found in Appendix XIV).

- In case it is not possible to take samples on site, single samples must be brought to a location where there are adequate conditions for sampling, a record of extra sample returning to the consignor must be made after sampling.
- In case the testing method requires a small sample size, after the analytical sample that represent a consignment are prepared, the extra sample shall be returned to the consignor.
