The following communication, received on 18 November 2025, is being circulated at the request of the Delegation of Brazil.

Draft Resolution 1333, 20 May 2025

Draft Resolution 1333, 20 May 2025 - previously notified through G/SPS/N/BRA/2412 - was adopted as Normative Instruction 392, 14 August 2025. The regulation proposes the inclusion of active ingredient B73 - BETAINE on the Monograph List of Active Ingredients for Pesticides, Household Cleaning Products and Wood Preservatives, which was published by Normative Instruction 103 on 19 October 2021 in the Brazilian Official Gazette (DOU - Diário Oficial da União).
