Draft Resolution 1340, 25 July 2025

Draft Resolution 1340, 25 July 2025 - previously notified through [G/SPS/N/BRA/2441](#) - was adopted as Normative Instruction 406, 21 November 2025. The regulation includes the Monograph of the active ingredient A73 - 2,3,5-TRIiodobenzoic acid on the Monograph List of Active Ingredients for Pesticides, Household Cleaning Products and Wood Preservatives, published by Normative Instruction 103 on 19 October 2021 in the Brazilian Official Gazette (DOU - Diário Oficial da União).
