Description of content:</b> The drafts complement the veterinary requirements of the EAEU by introducing confirmation of the well-being of the territory in part of chronic wasting disease (CWD) when importing animals of the deer family (Cervidae). They also set up veterinary requirements and a veterinary certificate form for non-human primates as laboratory animals.
