6. Description of content: The measure adopts Codex Maximum Residue Levels (CXLs) endorsed as new international food standards by the 48th session of the Codex Alimentarius Commission. CXLs are being adopted for the following active substances for a range of commodities: acetamiprid, azoxystrobin, cyclobutrifluram, etofenprox, fenpropidin, fipronil, flupyradifurone, difluoroacetic acid, folpet, pydiflumetofen, and tetraniliprole. The Evaluation Report/ Reasoned Opinion supporting the new MRLs is available at the following link: Evaluation Report and Reasoned Opinion on the Assessment of Codex MRLs - 2025.pdf The residue levels arising in food and feed from the notified uses result in consumer exposures below the toxicological reference values. As the residue levels exceed the current MRLs in force, new MRLs are being adopted.
