Addendum

The following communication, received on 29 April 2026, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limits: 1-Methylcyclopropene

The proposed maximum residue limit (PMRL) document for 1-methylcyclopropene notified in G/SPS/N/CAN/1631 (dated 28 January 2026) was adopted 26 April 2026. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.01 Avocados, bell peppers, broccoli, cantaloupes, cucumbers, peaches

¹ ppm = parts per million
