Draft Order of the Ministry of Health of Ukraine "On approval of the procedure and methodology for assessing the impact on human health of vitamins, minerals and other substances and their maximum permissible doses in food products offered for circulation as dietary supplements"

Ukraine notifies the adoption of the Order of the Ministry of Health of Ukraine No. 219 "On approval of the procedure and methodology for assessing the impact on human health of vitamins, minerals and other substances and their maximum permissible doses in food products offered for circulation as dietary supplements" of 20 February 2026.

The Order was registered in the Ministry of Justice of Ukraine on 10 April 2026.

It was officially published and entered into force on 28 April 2026.
