### *Addendum*

The following communication, received on 14 May 2026, is being circulated at the request of the Delegation of Brazil.

#### Draft Resolution 1383, 15 January 2026

Draft Resolution 1383, 15 January 2026 - previously notified through G/SPS/N/BRA/2471 - was adopted as Normative Instruction 443, 8 May 2026. The regulation includes the active ingredient I35—METHYL ICAFOLINE on the Monograph List of Active Ingredients for Pesticides, Household Cleaning Products and Wood Preservatives, which was published by Normative Instruction 103 on 19 October 2021 in the Brazilian Official Gazette (DOU - Diário Oficial da União).
