Draft Order of the Ministry of Economy, Environment and Agriculture of Ukraine "On Amendments to the Order of the Ministry of Agrarian Policy and Food of Ukraine No. 391 of 14 February 2024" (concerning the Requirements for fruit jams, jellies, marmalades and sweetened chestnut purée)

Ukraine notifies the adoption of the Order of the Ministry of Economy, Environment and Agriculture of Ukraine No. 4440 "On Amendments to the Order of the Ministry of Agrarian Policy and Food of Ukraine No. 391 of 14 February 2024" of 27 March 2026.

The Order was registered in the Ministry of Justice of Ukraine on 8 May 2026 and officially published on 26 May 2026.

The Order will enter into force on 26 November 2026.
