The following communication, received on 7 July 2026, is being circulated at the request of the Delegation of the European Union.

Measures to prevent the entry into, and the presence, establishment and spread within, the Union territory of Meloidogyne graminicola Golden & Birchfield

The proposal notified in [G/SPS/N/EU/932](#) (16 March 2026) is now adopted by Commission Implementing Regulation (EU) 2026/1433 of 3 July 2026 amending Annexes II, VII and VIII to Implementing Regulation (EU) 2019/2072 as regards measures to prevent the entry into, and the presence, establishment and spread within, the Union territory of Meloidogyne graminicola Golden & Birchfield.

This Regulation shall enter into force on the twentieth day following that of its publication in the Official Journal of the European Union.
