Description of content: The objective of the notified document PMRL2026-10 is to consult on the listed maximum residue limits (MRLs) for cyprodinil that have been proposed by Health Canada's Pesticides Regulatory Directorate (PRD). <u>MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 30 Abyssinian cabbages, arugula ² , Chinese broccoli ⁴ , garden cress ² , Hanover salad, maca, radish leaves ³ , seakale cabbages, shepherd's purse, turnip greens ³ , upland cress ² , wild rocket 0.4 Cranberries ⁵ ¹ ppm = parts per million ² This MRL is proposed to replace the current MRL of 50 ppm. ³ This MRL is proposed to replace the current MRL of 10 ppm. ⁴ This MRL is proposed to replace the current MRL of 1.0 ppm. ⁵ This MRL is proposed to replace the current MRL of 6.0 ppm.
