The following communication, received on 9 September 2026, is being circulated at the request of the Delegation of Brazil.

Draft Resolution 1.396, 4 May 2026

Draft Resolution 1.396, 4 May 2026 - previously notified through G/SPS/N/BRA/2489 - was adopted as Normative Instruction 465, 5 August 2026. The regulation proposes the inclusion of active ingredient S26 - SYZYGIUM AROMATICUM on the Monograph List of Active Ingredients for Pesticides, Household Cleaning Products and Wood Preservatives, which was published by Normative Instruction 103 on 19 October 2021 in the Brazilian Official Gazette (DOU - Diário Oficial da União).
