| 6. | <b>Description of content:</b> This Regulation authorises for the first time in the European Union and for a period of 10 years L-valine produced from <i>Corynebacterium glutamicum</i> KCCM 80366 as a feed additive belonging to the additive category 'nutritional additives' and in the functional group 'amino acids, their salts and analogues', for all animal species. This authorisation is based on the favourable conclusions of a scientific assessment of the dossier submitted by the applicant, conducted by the European Food Safety Authority (EFSA).
