The species (Keenan et. al., 1998) covered by this standard are the following: a) *Scylla serrata* (Giant mangrove crab); b) *Scylla olivacea* (Orange mangrove crab); c) *Scylla tranquebarica* (Purple mangrove crab); and d) *Scylla paramamosain* (Green mangrove crab).
