Description of content: The objective of the notified document PMRL2015-53 is to consult on the listed domestic maximum residue limits (MRLs) for cyazofamid that have been proposed by the Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)</u> <u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 12 Crop Subgroup 5B (Leafy Brassica Greens) 1.2 ¹ Crop Subgroup 5A (Head and Stem Brassica) ppm = parts per million ¹ The proposed MRLs of 1.2 ppm will replace the currently established MRLs of 0.02 ppm for Crop Subgroup 5A (Head and Stem Brassica). MRLs are proposed for each commodity included in the listed crop groupings in accordance with the <i>Residue Chemistry Crop Groups</i> webpage (http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/rccg-gcpcr-eng.php) in the Pesticides and Pest Management section of Health Canada's website.
