Description of content: As set out in the determination http://www.legislation.gov.au/Details/F2017L00034 , the Director of Biosecurity has suspended imports of uncooked prawns from all countries other than New Caledonia due to unacceptable biosecurity risk for a period of six months. The unacceptable biosecurity risk relates to the risk of uncooked prawn product carrying white spot syndrome virus (WSSV). |

| 8. Nature of the urgent problem(s) and reason for urgent action: To address biosecurity risks associated with imported uncooked prawns. Except for the current outbreak, WSSV is exotic to Australia. All prawn species imported into Australia are susceptible to WSSV. Therefore there is a high likelihood that WSSV could enter Australian territory with imported uncooked prawns. A suspension period of six months is necessary to analyse the information arising from inspections and investigations and to review import conditions. |
