Establish a provisory clause on the set point of shelf life of shell eggs;3. Modify phrase to clarify the set point of shelf life for mixed or simple processed products;4. Permit the distribution and sale of defrosted cheese and butter;5. Revise the methods of egg washing and establish the standard of storage for industrial eggs;6. Revise the standard of storage and usage for egg contents after egg breaking;7. Prohibit the centrifuging and crushing methods to obtain egg contents;8. Establish and revise the microbiological testing method;9. Modify the wording related to 'industrial egg' in the standards and specification for livestock products.
