If no, describe, whenever possible, how and why it deviates from the international standard: The current MRL of 1 ppm in milled rice will be deleted because the MRL of 2 ppm in rice has been set on the basis of the submitted data. MRLs in row agricultural commodities apply to their processed commodities (including milled rice) taking into account the processing factors, unless specific MRLs are set in the processed commodities. Therefore, the deletion of MRL in milled rice will not strengthen the current regulation, and all the proposed MRLs are taking into consideration Codex MRLs.

- **9. Other relevant documents and language(s) in which these are available:** Food Sanitation Act (available in English). When adopted, these MRLs are to be published in Kampo (Official Government Gazette) (available in Japanese).
