MRLs in row agricultural commodities apply to their processed commodities (including soybean oil and sunflower oil) taking into account the processing factors, unless specific MRLs are set in the processed commodities. Therefore, the deletion of MRLs in soybean oil and sunflower oil will not strengthen the current regulation, and all the proposed MRLs are taking into consideration Codex MRLs.</p>
