- 6. **Description of content:** These notified annexes to the draft Regulation set proposed maximum residue levels (MRLs) for the substances 2-phenylphenol, bensulfuron-methyl, dimethachlor and lufenuron. MRLs for these substances in certain commodities are changed: either increased or lowered. Lower MRLs are set after updating the limits of determination and/or deleting old uses which are not authorised any more in the European Union or for which a human health concern may not be excluded. The residue definitions of the substances have also been updated.
- Objective and rationale: [X] food safety, [] animal health, [] plant protection, [] protect humans from animal/plant pest or disease, [] protect territory from other damage from pests.
