Description of content: The objective of the notified document PMRL2017-22 is to consult on the listed domestic maximum residue limits (MRLs) for ethylene oxide and ethylene chlorohydrin that have been proposed by the Health Canada's Pest Management Regulatory Agency (PMRA). Ethylene oxide: <u>MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 7 Herbs (crop subgroup 19A; dried leaves except dried basil leaves); spices (crop subgroup 19B) ¹ ppm = parts per million Ethylene chlorohydrin: <u>MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 940 Herbs (crop subgroup 19A; dried leaves except dried basil leaves); spices (crop subgroup 19B) ¹ ppm = parts per million MRLs are proposed for each commodity included in the listed crop groupings in accordance with the <i>Residue Chemistry Crop Groups</i> webpage (http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/rccg-gcpcr-eng.php) in the Pesticides and Pest Management section of Health Canada's website.
