The scientific methodology used to establish MRLs is consistent with international practice. Members set MRLs according to the good agricultural practice (GAP) applicable to their respective conditions. Since pesticide use patterns differ between different production regions and Members as pests and environmental factors vary, Chinese MRLs for pesticides in food may differ from Codex standards.
