MRLs in raw agricultural commodities apply to their processed commodities (including dried pepper) taking into account the processing factors, as for Metaflumizone, the JMPR estimated the processing factor of 10 for dried pepper. Therefore, the deletion of MRL in dried pepper will not strengthen the current regulation, and all the proposed MRLs conform to the Codex MRLs.</p>
