Revise the maximum residual limits for pesticides and veterinary drugs:<ul style="list-style-type: none">– Establish MRLs for 22 insecticides (Methamidophos, etc.) for chicken meat and eggs;3. Revise General Test Methods:<ul style="list-style-type: none">– Expand veterinary drugs subjected to simultaneous test method;– Establish test methods for insecticides for chicken meat and eggs;– Establish simultaneous test method for mycotoxins in foods; and– Establish test method for additionally approved genetically modified foods.
