Description of content: The objective of the notified document PMRL2018-06 is to consult on the listed domestic maximum residue limits (MRLs) for ipconazole that have been proposed by the Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)¹</u> <u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 0.01 Edible-podded legume vegetables (Crop Subgroup 6A), succulent shelled pea and bean (Crop Subgroup 6B), mustard seeds (condiment type) ¹ ppm = parts per million MRLs are proposed for each commodity included in the listed crop groupings in accordance with the <i>Residue Chemistry Crop Groups</i> webpage (https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html) in the Pesticides and Pest Management section of Health Canada's website.
