Description of content: The objective of the notified document PMRL2018-08 is to consult on the listed domestic maximum residue limit (MRL) for flonicamid that has been proposed by the Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 1.5 Citrus fruits (Crop Group 10 – Revised) ¹ ppm = parts per million MRLs are proposed for each commodity included in the listed crop groupings in accordance with the <i>Residue Chemistry Crop Groups</i> webpage (https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html) in the Pesticides and Pest Management section of Health Canada's website.
