The dietary exposure to Acephate estimated by using the STMR of the supervised residue trials submitted to the JMPR and national food consumption data of these commodities would exceed an ADI of 0.0024 mg/kg bw/day which was set by the Food Safety Commission of Japan. Therefore Japan proposes the draft MRLs for these commodities based on the supervised residue trials for such plants which were conducted according to the Good Agricultural Practices (GAPs) in Japan. Japan also proposes deletion of the MRL in milk since Acephate is not permitted for use in milk in Japan and there are no supporting data submitted.</p>
