National authorisations of plant protection products containing this active substance were revoked by application of Commission Implementing Regulation (EU) 2017/244 of 10 February 2017 concerning the non-renewal of approval of the active substance linuron, notified to the WTO Committee on Technical Barriers to Trade (G/TBT/N/EU/409).
