6.	<b>Description of content:</b> This notified draft Regulation sets maximum residue levels for iprodione to the limit of determination by application of Article 14(1)(a) and Article 17 of Regulation (EC) No 396/2005 and following the revocation of national authorisations of plant protection products containing this active substance in the EU. National authorisations of plant protection products containing this active substance were revoked by application of Commission Implementing Regulation (EU) 2017/2091 of 14 November 2017 concerning the non-renewal of approval of the active substance iprodione, notified to the WTO Committee on Technical Barriers to Trade (G/TBT/N/EU/495).
