The amendment includes the following: <ul style="list-style-type: none">– The information of imported food, etc. that the result of inspection is appropriate is available on the website of MFDS;– The documents required for a declarer of imported food, etc. to ensure the safety of products in the process of customs clearance are simplified and the legal basis is clarified;– The facility standard for the business of online purchasing of imported food, etc. by proxy is mitigated so that it can conduct business without independent office.
