Description of content: The objective of the notified document PMRL2018-31 is to consult on the listed maximum residue limits (MRLs) for diquat that have been proposed by Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)¹</u> <u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 0.9 ² Dried shelled pea and bean, except soybean (crop subgroup 6C) ¹ ppm = parts per million ² This MRL is proposed to replace the currently established MRL of 0.2 ppm for all dried beans and peas listed in the MRL database. MRLs are proposed for each commodity included in the listed crop groupings in accordance with the <i>Residue Chemistry Crop Groups</i> webpage (https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html) in the Pesticides and Pest Management section of the Health Canada website.
