Description of content: The Food Safety and Inspection Service (FSIS) is proposing to amend the Siluriformes fish inspection regulations to list Viet Nam as a country eligible to export Siluriformes fish and fish products to the United States. FSIS is proposing this action because the Agency has reviewed Viet Nam's laws, regulations, and inspection system as implemented and has determined that Viet Nam's Siluriformes fish inspection system is equivalent to the system that the United States has established under the Federal Meat Inspection Act (FMIA) and its implementing regulations. Under this proposal, only raw Siluriformes fish and fish products produced in certified Vietnamese establishments would be eligible for export to the United States. All such products would continue to be subject to re-inspection at US points-of-entry by FSIS inspectors.
