The new import requirement was implemented starting from 1 July 2015 with a grace period of four months until 31 October 2015. Full implementation shall commence from 1 November 2015. 7. If no, describe, whenever possible, how and why it deviates from the international standard: On the New Import Requirements for Importation of Fresh Fruits of Mangosteen into Malaysia, there is no specific standard (ISPM) under the IPPC that is related to the importation of fresh fruits of mangosteen, however the proposed new import requirement does conform to other ISPMs e.g. ISPM 12 - Guidelines for phytosanitary certificates.
