<b>5. Title of the notified document:</b> Proposed Maximum Residue Limit: Cyazofamid (PMRL2019-05). <b>Language(s):</b> English and French. <b>Number of pages:</b> 5

Description of content:</b> The objective of the notified document PMRL2019-05 is to consult on the listed maximum residue limit (MRL) for cyazofamid that has been proposed by Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 0.9 Tomatoes subgroup (crop subgroup 8-09A) <sup>2</sup> <sup>1</sup> ppm = parts per million <sup>2</sup> The currently established MRL of 0.2 ppm for tomatoes is proposed to be revised to 0.9 ppm.
