Description of content: This standard specifies the technical requirements, sampling, test methods, inspection rules, labels, packaging, transportation, storage and shelf life of feed additive β -carotene powder. This standard is applicable to the feed additive β -carotene powder made from chemical synthesized β -carotene crystals and feed additives such as starch, gelatin and other excipients, which are sprayed, coated and dried. Chapters 1, 4, 6 and 7 of this standard are mandatory, while the rest are recommended.
