- **Description of content:** This Draft resolution incorporates the following changes for the active ingredient F36 FLUTRIAFOL (fenpropimorph) from the Relation of Monographies of Active Ingredients of Pesticides, Household Cleaning Products and Wood Preservers, all in the modality and use (application) on soil:
 - changes the MRL from 0.05 from 0.09 mg/kg for the coffee culture and mantains the safety security period of 120 days.

If no, describe, whenever possible, how and why it deviates from the international standard: The scientific methodology used by Brazil to establish MRLs is consistent with international best practice. Countries set MRLs according to the good agricultural practice (GAP) applicable to their region. Agricultural chemical use patterns differ between different production regions and countries as pests, diseases and environmental factors vary. This means that Brazilian MRLs for agricultural chemicals in food may differ from Codex standards.
