6.	<b>Description of content:</b> This Draft resolution incorporates the following changes for the active ingredient P34 - PIRIPROXIFEM from the Relation of Monographies of Active Ingredients of Pesticides, Household Cleaning Products and Wood Preservers: <ul style="list-style-type: none"><li>– includes cane sugar culture with MRL of 0.01 mg/kg and safety security period of 210 days;</li><li>– includes pasture for "non-food use", therefore there are not definition of LMR nor safety security period.</li></ul>

Countries set MRLs according to the good agricultural practice (GAP) applicable to their region. Agricultural chemical use patterns differ between different production regions and countries as pests, diseases and environmental factors vary. This means that Brazilian MRLs for agricultural chemicals in food may differ from Codex standards.</p>
