<b>6. Description of content:</b> Draft conditions for import of capsicum seeds for sowing into Thailand. Capsicum seed lots are required to fulfill at least one of the following phytosanitary import conditions: <ol style="list-style-type: none"><li>1. Capsicum seeds were produced in a pest free area or pest free place of production or pest free production site for <i>Clavibacter michiganensis</i> subsp. <i>michiganensis</i>, <i>Tomato brown rugose fruit virus</i>, <i>Columnea latent viroid</i> and <i>Potato spindle tuber viroid</i>;</li><li>2. Capsicum seeds were officially tested on sample of 3,000 seeds (or at least 10 percent of the lot as a small seed lot) using an appropriate genetic method and found free from <i>Clavibacter michiganensis</i> subsp. <i>michiganensis</i>, <i>Tomato brown rugose fruit virus</i>, <i>Columnea latent viroid</i> and <i>Potato spindle tuber viroid</i>.</li></ol>
