	 Revise the limit for 3-MCPD in acid-hydrolysed soy sauce and blended soy sauce; Establish a standard for amnesic shellfish poison (domoic acid) in shellfish and crustaceans; Revise the limit for heavy metal (lead) in 'Candies'; Establish "Foods containing milk or milk products" as a new food type for foods mainly made of milk or milk products which do not meet the definition of "Milk products"; Revise the maximum residual limits of pesticides for agricultural products:
	 70 pesticides including Glyphosate.
